Previous Minutes-

Resolved that: the presented Minutes were accepted as a correct record of Addingham Parish Council's Ordinary Meeting held on the 19th June 2013 and were duly signed by the Chairman.

Matters Arising- the Clerk had written re items raised:

BMDC Highways re Ragwort on the by-pass the steps on Coppy Road Pest Control re the family of rats at Saw Mill Steve Caw re the repairs needed at Back Beck Candy Squire re Totally Local

049/13 Correspondence regarding the Co-op retail store, Addingham Cricket Club.

Following receipt of a letter detailing problems caused by delivery lorries, i.e. number of daily visits, size and length of stay resulting in no cars being able to use the car-park and causing nuisance to neighbouring properties.

<u>Resolved that</u>: The Acting Clerk write to Co-operative Group highlighting the above issues and how they contravene assurances, given at the Licensing Panel Hearing that deliveries would be kept to two per day and lorry deliveries would be planned so as to create minimum disruption to neighbouring properties.

050/13 Addingham Totally Local Campaign

Cllr Tennant gave an update on how the above group was progressing. The meeting had been well attended with many businesses getting involved, this now included "Home" workers. Issues that currently cause concern were parking and the lack of people passing the village failing to take advantage of the services offered.

It was suggested that Memhall be approached to see if they could offer local workers parking facilities and that a sign be erected at the roundabout directing drivers into the village.

<u>Resolved that</u>: the PC support the campaign. Funding is not currently required, but the PC will at a future date consider paying for the roundabout sign

051/13 Various Leases

Following correspondence between the Council solicitor with both the Civic Society (MUGA Lease) and the Scout Leader (Scout Ht Lease)

Steven Butler is liaising with the Scouts re their lease, this should be cleared very soon.

There continues to be some problems to resolve re the MUGA, work is ongoing to deal with the Football Club sub-letting their premises, (changing facilities & toilets) and the level of insurance.

There were no resolutions.

052/13 Path leading from Memorial Car Park to Football Pavilion/Scout Hut

Following onsite meeting with Tim Brooks, Rights of Way Officer, BMDC. There are problems for wheelchair/pramusers.

- 1) If BMDC adopt the path, the cost of surfacing, lighting columns, handrail and low steps would be in excess of £10.000
- 2) BMDC could consider maintaining it on a Road to Road basis. To do this would cost £2,500 in legal fees plus maintenance costs.
- 3) The PC could continue to look after the path itself, but would need to resolve problems of the gradient and step heights.

Note: It is understood that the Civic Society is considering a "ZigZag" path, no knowledge as to who is funding the work.

Resolved that: The PC will look again at the options, Cllr Mawson to report back

053/13 Remembrance Sunday Service and Parade 2013.

Following correspondence received from Inspector S Sanderson

Resolved that: Members saw no reason to change the timings, these to remain as in previous years.

054/13 Path from Ridleys Fold to Southfield Terrace (JM)

Cllr John Mawson estimated the cost to be £145, in addition a Hawthorn tree needs pruning, Cllr Peter Hindle volunteered to assist with the work. The Gardening Friends will adopt the area once the remedial work has been done.

Resolved that: The PC accept the quote by Cllr John Mawson, £145

055/13 Village Bench Maintenance Programme.

Following an inspection by Cllr's Hindle and Mawson of the benches highlighted by Addingham Garden Friend as in need of maintenance works, and receiving a report on the condition of the benches. It was identified that there were 30 benches in a wide variety of condition. 6 require emergency work this summer. Some need the work doing in-situ whereas the others can be removed. It was estimated that the average cost would be £60 per bench.

Resolved that: That 10 benches be refurbished this year, with the others being done on a rolling programme. Budget set at £500 for the years 2014 onwards.

Resolved that: the PC have no objections.

057/13 Tour De France - BMDC Meeting

Cllr. Naylor updated the council on a meeting he had attended, organized by A. Ross, Sports Activity Officer, BMDC on Monday 8th July 2013. This meeting was not very well attended and little more information was available, this will increase once the exact route is disclosed in October.

West Yorkshire Police are the lead force, and the costs of organising the Grande Depart are estimated to be £21 million and rising.

BMDC are not supporting, at present, the amateur race for 15000 cyclists.

058/13 Civic Society Correspondence received

Resolved that:

- a) Toilet & Changing Facilities The civic society will be contacted shortly by PC to arrange a meeting with the Civic Society and the Football club to try to arrange a mutually agreeable solution. PC there as Landlords to facilitate the meeting.
- b) The PC thanked the Civic Society for informing it of their approach to the Co-operative for funding to meet the deficit on the completed MUGA.
- c) Planning Application at Farfield, this has been previously dealt with by the PC. It was only contacted by North Yorkshire as a matter of courtesy as the site is outside the Parish boundary.

Parish Council made our views to Planning Not in our jurisdiction, North Yorkshire

PC's main concern is to ensure that no traffic comes through Addingham village.

d) Xmas lights and torchlight procession – The PC decided that it did not consider it necessary to apply for a road closure and that the route from the churches and school should be restricted to the footpaths. Addingham Business Forum are considering a Xmas Market.

The PC does not consider it necessary for another working party.
